Finance Trust Bank may share your personal data with; its service providers and other third parties to comply with regulatory obligations and credit reference bureaus where credit products are applied for by you. All the personal information we share is subject to our privacy and security requirements and we are responsible for ensuring that your personal information is processed lawfully and in a reasonable manner that does not infringe your privacy rights.

The bank will keep your personal information only for as long as the law requires us to. After this time we will securely destroy this information.

You are required to keep your contact details up to date and ensure any cellphone number or email address that you have provided to us is functioning, you risk not receiving important communications from us, and you will solely be responsible where this affects your legal position.

You have the right to ask us for access to your personal information and to instruct us to amend and/or delete any personal data or to object to us processing your personal information. You can also let us know if you want us to stop or to limit how we use your personal information. If you do not agree with how we use your personal information, you can lodge a complaint with us.
