1. Security Supervisor

This position reports directly to the Manager - Security & Investigations and based at Head Office.

Role of the Job:

Maintains Bank safety and secure premises and personnel by patrolling property; monitoring surveillance equipment; inspecting buildings, equipment, and access points; permitting entry.

Key Result Areas:

- 1. Plan and coordinate operations of Physical Security officers in line with security policy and guidelines in accordance with the bank's Performance Management guidelines.
- **2.** Provide technical advice on requirements and specifications for existing and/or new building security systems including access control, intruder alarms, fire/smoke detection systems, and CCTV system.
- **3.** Undertake Security/emergency procedure checks to ensure compliance with regard to the bank's premises/physical security policy and standards, fire systems, fire prevention, access control, CCTV system and emergency procedures.
- **4.** Conduct Security awareness programs to all bank staff.
- **5.** Implement security risk assessment and review programs, ensuring timely identification of threats and development of cost-effective security counter measures.
- **6.** Coordinate crime detection, arrest of wrong doers and escort suspects to police in line with laid down security procedures.
- **7.** Receive, analyze periodic security reports received from branches and compile comprehensive physical security report as per laid down security guidelines.

- A Degree in a relevant field.

- Knowledge in investigation is an added advantage.
